Tournament Details

- Saturday, July 26 2014, starting at 9:00 a.m. at the Hollidaysburg Area YMCA (please arrive by 8:30)
- Registration cost is \$60 per team. ***Proceeds benefit Pancreatic Cancer Research***
- 2 Divisions of Play:
 - *FAMILY DIVISION* (all players must be related and include adults and children)
 - *RUN & GUN DIVISION*
- All teams are guaranteed at least 3 games in the round-robin portion of the tournament. A single-elimination playoff will be held in each division for teams that qualify from the round-robin.
- All games will be played on YMCA courts (indoor and outdoor).
- Any player can be a member of one team in each division, though scheduling accommodations will not be made for such situations. (In other words, make sure you have more than 3 players in case you have two games at the same time.)
- Round-robin games will have a 10-minute time limit and will not be held up for late arrivals.
- Games may begin with 1, 2, or 3 players. (Inbound-pass requirement will be waived for teams with one player present.)
- There will be a break between the round-robin and the single-elimination tournament. During the break, the SKILLS COMPETITION will be held including:
 - THE GRIFF RUNNER DUNK CONTEST (8'6" hoop)
