

To Whom It May Concern,

The Greg & Cathy Griffith Family Foundation, better known as "Sideline Cancer" is a 501c3 Tax-Exempt Organization that was founded in 2011 when Cathy Griffith's husband Greg was diagnosed with Stage IV Pancreatic Cancer and was given six weeks to live. Just 2 days prior, Greg had scored 38 points in a 40 and over men's league and was forced to cope with this devastating news. As a pillar of his community, people quickly came to his side, raising over \$2,000 to support him and his family during their challenging time. Greg heroically battled terminal cancer for 19 months, inspiring a community to form a foundation in his honor, "The Greg & Cathy Griffith Family Foundation" which later found its trademarked slogan of Sideline Cancer with the emphasis on the "I CAN." To date, the foundation has raised over \$300,000 for Pancreatic Cancer Research and nearly \$100,000 in assisting patients battling the financial hardships of cancer.

From 2012 to 2019, The Greg & Cathy Griffith Family Foundation was making annual donations to the research efforts of Greg's Doctor, A. James Moser of Harvard Medical. Dr. Moser was widely considered the best in his field and had a passion for curing this deadly disease. However, during the Covid-19 Pandemic in 2020, Dr. Moser decided it was time for him to retire and focus on his family. During this same time period, the foundation decided to make a pivot, gearing its platform to the patient instead of the research. At the turn of the year in 2022, Sideline Cancer hosted its first patient driven event at Bellwood-Antis High School, raising \$1,000 for the Miller Family, whose son Dawson played on the Bellwood Basketball Team, while his Father battled Colon Cancer. In the 24 months that followed, Sideline Cancer Events have raised nearly \$100,000 for patients in the Central, Pennsylvania area.

One of the primary benefits of the Sideline Cancer Patient Assistance Program is that 100% of your donation will go directly to a local member of your community. The money raised through donations of our local high school sporting events stays within the communities for which the events take place. Local businesses that support Sideline Cancer's Patient Assistance Program will receive a Tax-Exemption using our **EIN**, **Tax-ID Number (45-2815505).** Please make ALL checks payable to Sideline Cancer and on the memo-line please place one of the two; the patient's name or the school community your business is supporting (ie. Central Cambria School District). This information will allow us to easily identify the patient we are supporting.
